The plan will explain how the LEA will use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to implement a learning recovery program for at least the students included in one or more of the following groups: low-income students, English learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Parents were sent mini 1-2 question surveys once a week, as well as, being asked in the parking lot as they picked up their children what their concerns were regarding their children and school. Students took monthly “pulse” surveys on their social emotional standing, as well as a culture and climate survey that we take yearly. Teachers and staff were given many opportunities to share their concerns and what direction they would like to see New Tech go in and how best to serve our low income students. Our Advisory Leadership Board analyzed our data from the last two years and came up with their suggestions.

A description of how students will be identified and the needs of students will be assessed.

Transcripts were analyzed and all students with missing credits were asked to attend in-person summer school. In addition, the NWEA was given three times during the 2020-2021 school year. The data was analyzed for each student and students who were found to have gaps in learning in either math or language arts and are below grade level will be given one-on-one and small group tutoring sessions during the summer of 2021 by a paraprofessional who is good in both math and English. Grade 9 and 10 students also take the PSAT for their grade level and this data is analyzed and combined with the NWEA data. In the fall of 2021, the NWEA will be given once a quarter, to follow the growth of each student. For incoming grade 9 students, they will be given a diagnostic test in the spring of 2021 using the MDTP, and the use of the NWEA in the fall. 9th graders will be placed into math labs and or English lab classes (under 15 students) who need extra support in staying in their grade level math and English classes, or who need more intense catch up work over the year.

Families and students will be informed in the following ways:

- Phone call and contract for the requirement of summer school will go out to all families, who have students who are credit deficient for their grade, in early May. Summer school will be a combination of credit recovery by

both in-person, direct instruction and online instruction and practice with a certificated teacher in each classroom for that particular subject. Students will have opportunities to learn and participate in fun activities as well,

in order to help them stay engaged. Bussing will happen before, during and after each day. Summer school will go from June 7-July 2nd, 5 days per week.

- Before school starts in the fall families and students will be notified by letter, email, and phone call of the supplemental support that will be offered during the school year.
- Students will be referred and encouraged to attend support that is deemed necessary for their success.

Parent/teacher/student meetings will be planned when changes need to be made.

We have a lot of plans to supplement and support instruction for our students.

- We will hire an extra paraprofessional, one who will work with all students, not just our students on IEP's and 504's.
- Hire a new English teacher
- An extra math lab, one support of integrated math I and another for integrated math II.
- An English lab for support of all students
- In-person summer school costs for teachers, transportation, etc.
- Licenses for Edgenuity, NEWA, Nepris, etc.
- To give teachers stipends for after school intervention
- Maintaining our counselor full time.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

ELO Grant funds will be coordinated with ESSER funding allowing the various services described in the expenditure plan to extend into subsequent school years. ESSER funds will also be used to further support the extension of learning time, accelerating progress to close learning gaps, integrate student supports, support for credit deficient students, and provide professional development opportunities to staff. ESSER funds will be used to support summer school, afterschool tutoring, academic support through utilization of Edgenuity and NWEA software and professional development for social emotional learning. Additionally, a portion of ESSER funds will be used to ensure that operation of and continuity of existing core services of the charter school are maintained thereby allowing ELO Grant funds to be used for the purposes described in the plan. A MTSS grant was also awarded for the 2021-2022 school year and will be used for professional development of our staff to incorporate social emotional learning throughout the class and lesson plan, in addition to expanding our current MTSS program. The IPI grant will be used to pay for summer school costs, including transportation.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
